Judge Conti is a senior judge of the United States District Court for the Western District of Pennsylvania. Prior to her appointment, she was a shareholder with the Pittsburgh office of Buchanan Ingersoll, (now Buchanan Ingersoll Rooney), prior to which she was a partner with Kirkpatrick, Lockhart, Johnson & Hutchison, now known as K&L Gates LLP. Judge Conti was a Professor of Law at Duquesne University and taught courses on civil procedure, corporations, corporate finance, corporate reorganizations, and bankruptcy. She has written and lectured on eDiscovery and is a member of the prestigious American Law Institute and the American College of Bankruptcy.
