Regulation, Jurisdiction and Compliance: Tribal Regulatory Authority over E-Commerce

This panel will explore the range of regulatory regimes across Indian Country in the US and Canada. In many industries, e-commerce allows operators to select their regulator through an evaluation of that regulator's regulatory structure, cost and capacity. In the US, most tribes stick to self-regulating their own businesses, whether gaming, lending or online retail ventures. Panelists will explain the process for determining the scope of your tribe's regulatory authority over e-commerce, creating a culture of compliance and exploring the potential for both self-regulation and the marketing of regulation to others.
