	Recent computer hacks of Sony Pictures, the Democratic National Committee, the Chairman of the Clinton Presidential Campaign and federal government personnel files highlight the vulnerability of any online activity to persistent threats from foreign governments, black hat hackers, and organized international criminal gangs, all of which may sometimes collaborate with one another. Tribal online commerce collects and maintains all sorts of sensitive personal information on both employees and customers. In addition, tribal business records sometimes are vulnerable to such attacks. This panel will discuss such vulnerabilities and the risks for tribal e-commerce and how to mitigate them.

10:30 a.m. – Noon	The Future of Sports Betting: A New Playing Field?
	<ul> <li>The U.S. Supreme Court is currently considering the constitutionality of the Professional and Amateur Sports Protection Act (PASPA), which was designed to limit legal sports betting to a few states, primarily Nevada. While the outcome of the case is not certain, many jurisdictions are preparing for the federal ban to sports betting to be lifted. This panel will explore the federal case and its possible outcomes, with an emphasis on what it could mean for tribal governments and the tribal gaming industry. Panelists will also provide data on the current state of the sports betting industry, legal and illegal, to evaluate whether it is an amenity that tribal governments should pursue or ignore and the political tradeoffs that may be required for each approach.</li> <li>Kate Spilde, Ph.D., Associate Professor, L. #### **Exploring Sales Tax Issues for Indian Country Online Transactions**

Established rules governing state and local taxation may be obsolete as transactions increasingly take place on the "Web" and in the "Cloud," and both goods and services are "digital". The U.S. Supreme Court just agreed to address online tax issues for the first t ime, and it may overturn or s ignificantly modify the brightline physical presence test it recognized in Quill (1992). The panel will discuss current issues related to online transactions and the unique effects Indian law has on those issues, as well as how the Court and Congress could change the rules.


