The Future of Tribal Financial Services Regulation

One of the great myths in U.S. financial services is that all "tribal lenders" are illegal and "unregulated." In fact, a significant and growing number of American Indian tribal governments have financial services regulatory agencies to fill the same role as financial regulators at the state and federal level. Tribes that legally and safely regulate financial services have enormous potential for growing their economic development abilities, well beyond internet loans into broader markets like business and secured lending, insurance or other financial industries. This panel provides an overview of how tribes have exercised their sovereignty and laid a foundation for economic growth and jobs development by empowering tribal financial services regulatory authorities.
