

Holly Doremus is the James H. House and Hiram H. Hurd Professor of Environmental Regulation at the University of California, Berkeley, Associate Dean for Faculty Development and Research, and Co-Faculty Director of the Center for Law, Energy, and the Environment. She serves on the Board of Directors of Defenders of Wildlife and on California's Ocean Protection Council Science Advisory Team.
