Dorothy J. Glancy is Professor of Law at Santa Clara University School of Law. Technology and Law issues related to transportation, land use, and Intelligent Transportation Systems are among her areas of expertise. She is a member of the National Academies of Sciences Committee on the Long-Term Stewardship of Driver Safety Data (SHRP 2), directed a multi-year research project regarding the impact of intelligent transportation systems on privacy, and assisted in developing the Department of Transportation's Vehicle Infrastructure Integration program. She has been a consultant to the Vehicle Safety Communications Consortium 3 (VIIC) and, with Cambridge Systematics, helped prepare a Rural Interstate Corridor Communications Study Report to Congress for the Federal Highway Administration. In California, she assisted with the design and operation of the FasTrak® toll-tag-based Bay Area traffic information collection system, Traffic Watch. Her seminal article, "Privacy in Autonomous Vehicles" is an example of her views about autonomous car. Professor Glancy has written extensively about Event Data Recorders and conducted an international comparative study of "Privacy Protection in Traffic Surveillance Cyberinfrastructures." She has also worked with the American Association of Motor Vehicle Administrators with regard to drivers' and vehicle licenses.

Professor Glancy holds degrees from Wellesley College (B.A.) and Harvard Law School (J.D.). She served as counsel to the United States Senate Judiciary Subcommittee on Constitutional Rights and served in the Office of General Counsel of the Department of Agriculture. She is a Research Fellow of the Gruter Institute for Law and Behavioral Research, a Life Member of the American Law Institute and a member of the California Judicial Council's Court Technology Advisory Committee.

Her publications cover a wide range of topics, including land use, historic preservation, autonomous vehicles, Intelligent Transportation Systems, and privacy.
