NNALSA was founded in 1970 to support law students who are interested in the study of Federal Indian Law, Tribal Law, and traditional forms of governance. Each year, NNALSA holds a moot court competition for law students who have a passion for Indian law and litigation. This event attracts hundreds of law student competitors, professors, practitioners, and scholars. Law schools across the nation submit bids to host this prestigious event, and we are honored that this year's competition will be held in the Valley of the Sun!

Throughout the academic year, competition teams will conduct intensive legal research to write an appellate brief and prepare oral arguments. The ability to argue in front of a knowledgeable judicial panel affords the students an opportunity to further hone their advocacy and persuasive argument skills. In addition to oral argument rounds, this year's competition will include a CLE course, networking events, and an awards banquet featuring speakers from the Indian Law community and performances by artists representing local tribal nations. These events allow attendees both to engage and connect with the local Native and legal communities, and explore Downtown Phoenix.

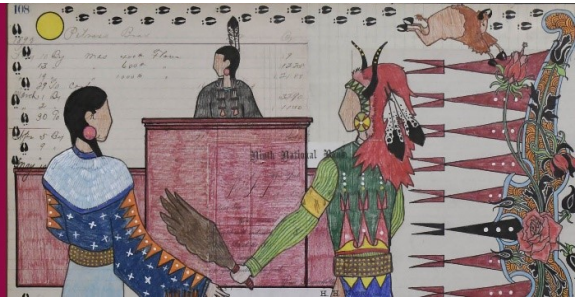
